**THESE SHOWS WILL BE HELD OUTDOORS REGARDLESS OF WEATHER**

1. Entries will close at 6:00 pm, Wednesday, MARCH 16, 2011 after which time entries cannot be accepted, cancelled, changed or substituted, except as provided for in Chapter 11, Section 6 of the Dog Show Rules; and no entry fees will be refunded.
2. Entries not on Official AKC Forms or photocopies of entry forms without the agreement and rules on the reverse side of the Official AKC entry form are not acceptable. Entry Form must show the name of the Club and date of show.
3. Dogs need be present only for their judging. Dogs not needed for further judging may be removed from the show grounds. There are no provisions for unentered dogs at this show.
4. It is advised that owners and agents be familiar with the Agreement on the reverse side of the entry form.
5. Exhibitors should follow their veterinarians recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
6. To transfer a Conformation dog from one of the regular classes to Best of Breed Competition or to transfer an Obedience or Rally entry to the next higher class requires that the owner or agent notify the Show Secretary at least one half hour prior to the judging of the first class of each show.
7. The entry forms in this premium list may be used for both shows. Please check the appropriate box of the show/shows you wish to enter your dog. This eliminates the need to fill out two entry forms for one dog.
8. To have a dog listed as being OFA Certified in the Catalogue, the OFA NUMBER must be included on the Entry Form behind the dog's name.
9. The Obedience Trial is open to all breeds with the following stipulations:  
Total entries are limited to forty five. Each of the six regular classes are not individually limited. All German Shepherd Dogs will have priority entries. Each class entry will be listed in the order received, regardless of breed. All breeds will be judged together. First place through fourth place will be judged for all breeds within the class. Following these placements, first through fourth place will be awarded for German Shepherd Dogs only. German Shepherd Dogs may receive both all-breed and German Shepherd Dog only awards in the same class. There are two sets of trophies for first in each class and the HIT and High Combined, one for GSD's and the other for all breeds. The GSDCA Bronze Medal for High Combined is awarded only to GSD's.
10. The Rally Trial is open to all breeds with the following stipulations:  
Total entries are limited to sixty. Each of the six regular classes are not individually limited. All German Shepherd Dogs will have priority entries. Each class entry will be listed in the order received and by jump height, regardless of breed. All breeds will be judged together. First place through fourth place will be judged for all breeds within the class. Following these placements, first through fourth place will be awarded for German Shepherd Dogs only. German Shepherd Dogs may receive both all-breed and German Shepherd Dog only awards in the same class. There are two sets of trophies for first in each class.
